Trinity County Coronavirus (COVID-19) Health Advisory

TRINITY COUNTY – In order to be completely transparent and accurate, Trinity County Public Health Branch (TCPHB) has reviewed positivity data more closely and developed a process for ensuring timely, complete data is communicated to our residents, partners, and media outlets. A retrospective review of all data shows that from August 1, 2021 to September 2, 2021 Trinity County has seen 234 positive cases. Beginning the week of September 15, 2021, we will add the following positive test categories to our Case Dashboard:

- Number of Unvaccinated Testing Positive; defined as:
 - Persons 12 years of age and older testing positive that have not received any doses of COVID-19 vaccine.
 - Persons 11 years of age and younger not eligible to receive vaccination.
- Number Partially Vaccinated Testing Positive; defined as:
 - Individuals who have received only one dose of a two (2) dose series of vaccine and test positive.
- Number Vaccinated But Not Yet Protected Testing Positive; defined as:
 - An individual who has completed the covid-19 vaccination series (1-dose Janssen or 2-dose Pfizer or Moderna) but tests positive before the two (2) weeks post vaccination needed to ensure protection (build antibodies from vaccination).
- Number of Fully Vaccinated Individuals Testing Positive; defined as:
 - An individual who has completed the covid-19 vaccination series (1-dose Janssen or 2-dose Pfizer or Moderna) two (2) weeks prior to the positive test

Of the 234 positive cases since August 1, 2021:

- Number of unvaccinated testing positive 12 years of age and older = 178
 - Hospitalizations = 11
 - Deaths = 3

- Number of unvaccinated testing positive 11 years of age and younger = 16
 - Hospitalizations = 0
 - Deaths = 0

- Number partially vaccinated testing positive = 2
 - Hospitalizations = 0
 - Deaths = 0

- Number vaccinated but not yet protected testing positive = 1
 - Hospitalizations = 0
 - Deaths = 0

- Number of fully vaccinated individuals testing positive = 37
 - Hospitalizations = 1
 - Deaths = 0
